Item No. 3: To peruse the statement of accounts submitted by office of the Secretary, Admissions Regulating Authority for the period dated 01/03/2019 to 31/03/2019.

The Authority perused and noted the Statement of Accounts, the details of which are marked as **Annexure - A.**

Item No. 4: To consider and decide on the office note dated 16/04/2019 w.r.t. admission details of students admitted in Post Graduate Dental course for the Academic Year 2018-19 of Aditya Dental College, Beed.

The Authority perused the aforesaid letter received from Aditya Dental College, Beed along with office note dated 16/04/2019 regarding approval of students admitted of First Year BDS and MDS course for the Academic Year 2018-19.

The Secretary, Admissions Regulating Authority, Mumbai pointed out that the aforesaid College/Institute did not complete the procedure of 'Registration Process' within the stipulated time period i.e. from 6/09/2018 to 31/01/2019 on Authority's www.safalta.org portal for the approval of admission process for the Academic Year 2018-19 even after various reminders.

The aforesaid College/Institute has paid the penalty and completed the 'Registration Process' on 5/03/2019 of MDS course and uploaded scanned copies of documents on Safalta Portal but the same were not verified as all documents of BDS students were sent to Maharashtra University of Health Sciences, Nashik, for eligibility of students by the Institute, hence admissions of admitted MDS and BDS candidates were not approved for the Academic Year 2018-19.

In view of the above, after deliberations, considering the academic welfare of the students, the Authority directs the Secretary, Admissions Regulating Authority, Mumbai to verify and scrutinize the admissions. The Authority further directs the Secretary, Admissions Regulating Authority to communicate the verification report to the Maharashtra University of Health Sciences, Nashik, subject to final approval of the Authority, where there are no discrepancies in the admissions of Aditya Dental College, Beed for the Under Graduate and Post Graduate Dental Courses for the Academic Year 2018-19. Office to inform accordingly.

Part-I: Medical Education

Item No. 5: To ratify the action taken by the Secretary, Admissions Regulating Authority, Mumbai w.r.t. report submitted by the Enquiry Committee in the matter of Civil Appeal No. 5700 of 2018 viz. Ulhas Patil Medical College, Jalgaon.

The Authority perused the details submitted by the office w.r.t. report submitted by the Enquiry Committee in the matter of Civil Appeal No. 5700 of 2018 regarding admissions of students admitted after last CAP round at Institute Level for First Year MBBS course in the Academic Year 2012-13 of Dr. Ulhas Patil Medical College, Jalgaon.

The Authority also perused the letter dated 3/04/2019 received from Mr. Dayanand Manjramkar requesting for implementation of Supreme Court order in Civil Appeal No. 5700 of 2018 SLP (C) 9889 of 2018.

The Authority went through the report submitted by the Dr. A.S. Vyas and Dr. P.R. Raikar w.r.t. various complaints related to institute level admission process conducted at Dr. Ulhas Patil Medical College, Jalgaon for Academic Year 2012-13.

The Authority also went through the order dated 31/08/2018 of the Hon'ble Supreme Court of India, New Delhi in M.A. No. 2198 of 2018 in Civil Appeal No(s). 5700 of 2018, the extract of the same is reproduced hereunder, -

"..... It was submitted that seven students had already been paid the amount. Whatever payment has to be made let it be made as per the order only. In case the Government has paid the amount to seven students, that part of the amount can be remitted to the Government.

It is conceded that the order has been complied with by the institution, as such compliance is recorded.

Let the names of the students, who are required to be paid, be ascertained within three months and compliance be reported to this Court by the P.N. Samiti.

M.A. Accordingly disposed of."

The Authority once again went through the the decision taken in the then Pravesh Niyantran Samiti's Meeting held on 15/10/2015 at Item No. 03 & 04 the penalty was imposed for regularizing the admissions to the Colleges/Institutes for their illegal, irregular, unjust, biased admissions done in Academic Year 2012-13.

In view of the above, after deliberations, the Authority ratifies the decision taken by the Secretary, Admissions Regulating Authority, Mumbai w.r.t. report submitted by the Enquiry Committee in the matter of Civil Appeal No. 5700 of 2018 as follows,-

1. As per the findings of the Enquiry Committee Report, the office of the Authority paid the compensation to the said seven students and remaining amount to be submitted to the Government of Maharashtra as per the order of the Hon'ble Supreme Court of India.
2. The Approval given to the 19 students of the Dr. Ulhas Patil Medical College, Jalgaon.
3. Compliance report submitted before the Hon'ble Supreme Court of India, New Delhi.

The Authority further decides that, on the basis of the order dated 31/08/2018 of Hon'ble Supreme Court of India, New Delhi in M.A. No. 2198 of 2018 in Civil Appeal No(s). 5700 of 2018 and report submitted by the Enquiry Committee the request made by the Mr. Dayanand Manjramkar for compensation is not to be acceded, as he received compensation as per the order dated 2/9/2014 in the matter Special Leave Petition No(s). 31900 of 2013.

The Authority went through the decision taken by the Authority in its meeting held on 20/02/2019 at Item No. 20.

In view of the above, after deliberations, the Authority directs the Directorate of AYUSH, Mumbai to verify/scrutinize the aforesaid admissions and submit their report student-wise to the Authority at the earliest. After receipt of the same, it will be placed before Authority for its appropriate action. Office to take necessary steps.

Item No. 7: To apprise the Authority the orders dated 2/4/2019 and 8/4/2019 of the Hon'ble High Court, bench at Nagpur in Writ Petition Nos. 1837, 1854, 258, 952, 7591, 7595 of 2019 in the matter of students of S.D. Kalmegh Dental College, Nagpur admitted in NRI Quota.

The Authority perused the aforesaid orders of the Hon'ble High Court, bench at Nagpur in Writ Petition Nos. 1837, 1854, 257, 258, 952, 7591, 7595 of 2019 in the matter of students of Swargiya Dadasaheb Kalmegh Dental College, Nagpur admitted in NRI Quota.

The Authority went through the decision taken in its meeting held on 28/09/2018 at Item No. 11(b) and 11(c).

It is noticed that the Authority in its meeting held on 28/09/2018 (at Item No. 11[b] and 11[c]) impose the penalty of 02 times of the fees /per candidate fixed by the Fees Regulating Authority/Shikshan Shulka Samiti for admitted Academic Year of the students, where the relation between sponsor and candidates is other than First Degree Blood relative as per the decision taken by the earlier Pravesh Niyantaran Samiti in its meeting held on 27/09/2007 at Item No. 3 and imposed penalty of Rs. 10 lakh, per candidate, where the NRI status of sponsor and relation between sponsor is not proved, for their illegal, irregular, unjust, biased and wrongful admissions.

After deliberations, the Authority decides that the said orders of the Hon'ble High Court to be obeyed and decided to review the order of Hon'ble High court in Writ Petition Nos. 1854, 258, 952, 7591, 7595 of 2019 in time. Office to inform accordingly and take necessary actions.

Candidate should verify the correctness of entries made in application form. There is no provision to make changes in the application form once Submit Button is clicked."

In view of the above, after deliberations, the Authority decides not to accede the requests made by the Annuja S. Warke and Dr. Swapnali Nikam regarding change of category from Open to OBC and Open to SEBC for the admission to Post Graduate Dental Courses for the Academic Year 2019-20. Office to inform accordingly.

Item No. 16: To consider and decide on the letter dated 28th March 2019 received from Dr. Tanvi R. Patil, Mumbai regarding appeal for information w.r.t NEET-PG-2019 admissions.

The Authority perused the letter dated 28/03/2019 received from Dr. Tanvi R. Patil regarding appeal for information and requesting to grant time to submit the Caste Validity Certificate.

The Authority perused the aforesaid email dated received from Adv. Nahush Khubalkar submitted opinion w.r.t. Order of the Hon'ble High Court in Writ Petition No. 2330 of 2019 and letter dated 20/04/2019 received from Dr. Abhilash Vilas Kavitkar in the subject matter.

The Authority heard Dr. Abhilash Kavitkar along with his Advocate.

At the time of hearing, the candidate requested to allow him to change his preferences cum choices during second round for the admission to Post Graduate Medical Courses for the Academic Year 2019-20, but it is made it clear that as per the Rule No. 14.1 of the information brochure of NEET-PG-2019, there is no provisions to change the preference(s). Dr. Abhilash Kavitkar and his Advocate were also convinced during hearing, accordingly.

In view of the above, after deliberations, the Authority directs the Commissioner and Competent Authority, State CET-Cell, Mumbai to consider the case of Dr. Abhilash Kavitkar in second round as per the merit cum preferences. Office to take necessary steps and inform accordingly.
