In view of the provisions of section 9 sub section (3) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. Act No. XXVIII of 2015) which came into force on 12<sup>th</sup> May, 2015, **the Pravesh Niyantaran Samiti existing as on the date of commencement of the Act continues to exercise the powers of the Admissions Regulating Authority till such Authority is duly constituted under the Act.**

**Item No. 1: To approve and confirm the Minutes of Meetings of the Admissions Regulating Authority held on Saturday, 15<sup>th</sup> December 2018 at Conference Hall, Office of the Admissions Regulating Authority, Mumbai.**

The Director, Technical Education, Mumbai requested that decision taken by the Authority in its meeting held on 29<sup>th</sup> November 2018 at Item No. 23 w.r.t. the admission of Ku. Rashmi Baitule be modified. The Director requested the Authority to remove the last few lines before the minutes are confirmed and approved.

The Secretary, Admissions Regulating Authority submitted that at the time of hearing held on 14/11/2018 before the Secretary, Admissions Regulating Authority, Mumbai in the case of Ku. Rashmi Baitule the Officers of the Directorate of Technical Education, Mumbai, representative of College/Institute and student/parent were present. Ku. Rashmi Baitule and her parent stated that due to cancellation of her admission she lost her Academic Years. She also suffered from various personal issues. During the hearing it is noticed that various students like Ku. Rashmi Baitule were verified and confirmed their admissions at verification stage. However only the admission of Ku. Rashmi Baitule was not confirmed and subsequently cancelled. Thus injustice happened

with only Ku. Rashmi Baitule. Therefore, if Ku. Rashmi Baitule claims for compensation then the concerned Directorate is liable to pay the same.

The Authority noted that the candidate has not claimed any compensation so far. In view of the above, the Authority after deliberations, decided to approve and confirm the minutes of the meeting held on 29th November, 2018 with following modification.

**A) Item No. 23 (Page No. 13/14) para No. 04 should be read as under :-**

*"In view of the above, after deliberations, the Authority decides to restore the admission of Ku. Rashmi Baitule in MCA course admitted in Academic Year 2016-17, on the basis of aforesaid letter of Directorate of Technical Education, Mumbai, subject to accommodation of Ku. Rashmi Baitule in suitable College/Institute as per her choice by the Directorate of Technical Education, Mumbai. Office to inform accordingly."*

"In view of the above, after deliberations, the Authority decides to restore the admission of Ku. Rashmi Baitule in MCA course admitted in Academic Year 2016-17, on the basis of aforesaid letter of Directorate of Technical Education, Mumbai, subject to accommodation of Ku. Rashmi Baitule in suitable College/Institute as per her choice by the Directorate of Technical Education, Mumbai. It is made clear that if the Ku. Rashmi Baitule asked for any compensation then the concerned Directorate is liable to pay the same. Office to inform accordingly."

**Item No. 4: To discuss and decide on the draft report submitted by the Committee w.r.t. Regulations of day to day working of the Authority.**

The Authority perused the draft of Regulations prepared by the subcommittee for day to day working of the Authority. During discussion, it was informed that the regulation are prepared as per section 24 of the Act, 2015. However as per section 23 the Rules under the said act are required to be prepared by the Government and notified in the Gazette. It was, therefore decided that the draft regulations under the Act will be considered once the rules are notified by the Government. The Authority also directed office to informed the same to Government. Office to take necessary action.

**Item No. 5: To discuss and decide w.r.t. appointment of Advocates on Panel on behalf of respective Directorates as respondents in CET/CAP matters arises before High Court of Bombay bench at Mumbai, Aurangabad and Nagpur.**

The Authority perused the details submitted by the Secretary, Admissions Regulating Authority, Mumbai w.r.t. appointment of Advocates on Panel on behalf of the Authority, State CET-Cell as well as respective Directorates as respondents in CET/CAP matters arises before the Hon'ble High Court of Bombay bench at Mumbai, Aurangabad and Nagpur.

After deliberations, the Authority approved the proposals w.r.t. appointment of Advocates in the panel of Authority, State CET-Cell as well as for respective Directorates for legal matters, which would arise hereinafter in the Bombay High Court, Bench at Mumbai, Aurangabad and Nagpur, as the case may be. Authority further decides that, where Authority, State CET-Cell and concerned Directorate as a Nodal Officer are respondent in the matter, then the impanel Advocate should appear on behalf of these three respondents. In cases, the senior Councilors are required the respective Directorates may appoint Senior Advocate with due approval from Commissioner, State CET-Cell.

**Item No. 6: To discuss and decide on the letter dated 1/12/2018 received from Directorate of Higher Education, Pune w.r.t. the verification and thereon approval of admissions of admitted students through CAP for the Academic Year 2018-19, ref. office letter dated 30/11/2018.**

The Authority also perused the letter dated 30/11/2018 issued by Secretary, Admissions Regulating authority, Mumbai.

The Secretary, Admissions Regulating authority, Mumbai has drawn attention of the Authority to the provisions of the Maharashtra Unaided Private Professional Education Institutions (Regulations of Admissions and Fees) Act, 2015 wherein it is mandatory to approve all the admissions in Maharashtra Unaided Private Professional Education Institutions on or before 31<sup>st</sup> January of every year. The Secretary, Admissions Regulating Authority, Mumbai informed that all the concerned Nodal

Officers/Directorates have been communicated vide letter dated 30/11/2018, to report Authority about eligibility of admitted student whoever admitted through CAP, since they have already verified the requisite documents through ARC/FC during admission process. The Directorate/Nodal Officers will have to verify, scrutinize the admission process for admissions done at Institute Level. Secretary, Admissions Regulating Authority, Mumbai informed that all the data of admitted students, either through CAP or at Institute Level, is available on Online Portal www.maha-ara.org (www.safalta.org) and Directorates have already been given Login Id and Password for verification. The Authority also went through the decision taken at Item No. 5 at its meeting held on 28/09/2018.

After deliberations the Authority directed all the Nodal Officers/Directorate to verify and scrutinize the admissions made in the Academic Year 2018-19 through their login and submit their report on or before 31<sup>st</sup> December, 2018. The Authority perused the aforesaid letter received from Directorate of Medical Education and Research, Mumbai w.r.t. draft Rules for admission process of Post Graduate Medical and Dental Courses for the Academic Year 2019-20. Noted.

**Item No. 14: To discuss and decide on the following letters w.r.t. issues related to the Observer for the Institute Level admission process for the Academic Year 2018-19,-**

i) **Letter dated 29/11/2018 of State CET-Cell, Mumbai.**

ii) **Letter dated 7/12/2018 of Directorate of Medical Education and Research, Mumbai.**

The Authority perused the aforesaid letters.

Commissioner, State CET-Cell pointed out that State CET-Cell had appointed Observers from different Government Medical Colleges at the time of Institute level admission process of MBBS course during the 28/08/2018 to 31/08/2018, out of which one of the Observer didn't report to College and didn't inform CET-Cell regarding his inability to work as Observer. Commissioner further stated that one of the Observer was appointed at Prakash Institute of Medical Science, Sangli. Total 05 vacancies were declared by State CET-Cell for 85% quota, but later this office noticed that two more vacancies were created on 30/08/2018 in 85% Quota which were approved by Observer and two new vacancies were not informed to State CET-Cell and State CET-Cell has not given permission or any guidelines to fill in these two vacancies.

In this connection State CET-Cell, Mumbai vide its letter dated 29/11/2018 directed to take strict action against these two observers, and informed accordingly to Directorate of Medical Education and Research, Mumbai vide its letter dated 07/12/2018 that these two Observers were not to be appointed as Observer in any Institutional level round, hereafter.

Authority approved the action taken by Commissioner, State CET-Cell. Authority further directs to get the certified list of Observers (Officer not below the rank of Grade-I) from all concerned Directorates for CET/CAP process of Academic Year 2019-20 and forward the same to Government of Maharashtra through Secretary, Higher and Technical Education Department, Mumbai for their necessary approvals w.r.t. appointment of Observer as State CET-Cell and Admissions Regulating Authority, Mumbai. Office to take necessary steps.

iii) **Letter dated 28/11/2018 of Prakash Institute of Medical Sciences & Research, Islampur.**

Secretary, Admissions Regulating Authority pointed out that as per the decision taken by the Authority in its meeting held on 24/07/2018 at Item No. 14, the Aditya College of Architecture, Borivali, Mumbai has paid the requisite penalty amount, but aforesaid College/Institute yet not paid the same. Further Secretary, Admissions Regulating Authority, Mumbai added that due to non compliance from aforesaid College/Institute the transfer of admission of Ku. Akshay Gaikwad still not regularized by the Authority.

In view of the above, after deliberations, Authority decides to regularize the transfer of admission of Ku. Akshay Gaikwad. Authority further decides not to accede to the request submitted by College/Institute to waive the penalty. It is also decided not to regularize the admission of Ideal Institute of Architecture, Palghar for the Academic Year 2018-19 onwards, due to non compliance of the decision of Authority. Office to take necessary actions and inform accordingly.


