The Colleges/Institutes were permitted to complete the process imposing penalty of Rs. 1000/- per candidate and maximum upto Rs. 25,000/- per College/Institute, after receiving of various request to the Authority.

The Authority made it clear that all Private and Unaided (including University managed / self finance) Professional educational Colleges/Institutes are liable to pay the 'Processing Fees' as prescribed by the Admissions Regulating Authority in its meeting held on 29<sup>th</sup> June 2018 at Item No. 27(a) including penalty for delay in 'Registration Process'.

In view of the above, after deliberations, considering the Academic welfare of the student admitted in Academic Year 2018-19 in various professional courses, the Authority decides to extend the date for 'Registration Process' from 1/12/2018 to 5/12/2018 with the penalty of Rs. 2,000/- per candidate and maximum upto of Rs. 50,000/- per institute. 


