Reservation for N.R.I. for various professional courses

This is in continuation of the Note, dtd.31.5.2023 (copy enclosed) regarding N.R.I.

During my visit to New Delhi from 24.7.2023 to 27.7.2023, I had discussion with various Chairmen/Member Secretaries of the Apex Bodies/Authorities like National Medical Commission, All India Council for Technical Education, etc. This is regarding candidates who should be eligible for getting admission under NRI quota.

The definition of the N.R.I. prescribed in the Maharashtra Unaided Private Professional Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah.Act No.XXVIII of 2015), under Section 2(n) is as follows -

“Non-Resident Indian (NRI)” means a person who is “not ordinarily resident” under sub-section (6) of Section 6 of the Income Tax Act, 1961, and includes a person resident outside India under clause (w) of section 2 of the Foreign Exchange Management Act, 1999, and also includes his child or ward.”

It is clear that we have to follow this definition of NRI. You are requested to put up immediately implementing this definition since it is in the Act of 2015. The guidelines given by the Admissions Regulating Committee (A.R.C.) long back when this Act of 2015 was not passed, stands superceded by this Act and hence from now onwards, we have to follow the legal procedure contained in the Act of 2015. A person who is NRI, as per the definition of the Act, will get benefit of admissions in NRI quota only for his son and daughter.

Put up accordingly.

Reservation for N.R.I. for various professional courses

The definition of the N.R.I. prescribed in the Maharashtra Unaided Private Professional Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah.Act No.XXVIII of 2015), is as follows

“Non-Resident Indian (NRI)” means a person who is “not ordinarily resident” under sub-section (6) of Section 6 of the Income Tax Act, 1961, and includes a person resident outside India under clause (w) of section 2 of the Foreign Exchange Management Act, 1999, and also includes his child or ward.”

When I visited the Madhya Pradesh recently and discussed with the concerned Secretaries of the Govt. of Madhya Pradesh, regarding N.R.I., they have prescribed some proforma in which N.R.I. candidates and his concerned have to submit some documents as shown in their proforma (copy enclosed).

We have to adopt this proforma, in addition to whatever has been prescribed by the then Admissions Regulating Committee (A.R.C.). These changes should be incorporated in our admission process and accordingly in Admission Rules and Annexures, if any, have to be modified accordingly.
