**Item No. 4: To consider and decide w.r.t. the proposals where there are discrepancies found in selected candidates of various Professional Educational Courses for the Academic Year 2018-19.**

The Secretary, Admissions Regulating Authority pointed out that, as per sub clause (iii) of clause (5) of section 9 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 it is mandate to scrutinize and approve the admissions in Academic Year 2018-19 on or before 31<sup>st</sup> January 2019. However as per the report received from M/s. Kalp Technologies, Pune as third party verification process of Admissions for the Academic Year 2018-19, the total 13287 (out of which 8963 students admitted in Government/Aided/Corporation Colleges/Institutes and 4324 is students admitted in Private and Unaided Colleges/Institutes) admissions are not approved by the Authority, due to certain discrepancies pointed out by the M/s. Kalp Technologies, Pune.

In view of the above, after deliberations, Considering broader interest and academic welfare of the student, the Authority decides to suggest the Higher and Technical Education Department, Government of Maharashtra to take the necessary steps in respect to Section 9, sub-section (5), clause (iii) of the Act, 2015 at the earliest and inform the Authority accordingly. In view of the above, after deliberations, the Authority directs the Secretary, Admissions Regulating Authority, Mumbai to start the College/Course registration process of all Professional Educational Colleges/Institutes for the Academic Year 2019-20 from the 1<sup>st</sup> April 2019 to 30<sup>th</sup> April 2019. The concern Directorates also give all information regarding registration of College for CAP.

The Authority further directs the all concerned Directorates to submit the undertaking mentioning therein that the provisions of Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 are binding to all Government / Aided / Corporation / Minority Colleges/Institutes for implementation of Government resolutions issued time to time for the admissions process will be conducted by the Commissioner and Competent Authority, State CET-Cell, Mumbai for the Academic Year 2019-20 and onwards.

The Secretary, Admissions Regulating Authority, Mumbai submitted that as per the directions of the Authority all Government / Aided / Corporation / Private Unaided Colleges/Institutes are registered on Authority's Safalta Portal for the Academic Year 2018-19. During this process it is noticed that admissions of 68 students admitted in Institute of Chemical Technology (ICT), Mumbai at Institute level for the Academic Year 2018-19 were not updated on DTE as well CET portal by the aforesaid College/Institute and the last date to update the same was 31/08/2018. However, the Authority call the explanation from the Nodal Officer/ Director, Technical Education, Mumbai in this respect.
