The Authority perused the aforesaid letters received from the Annasaheb Dange Ayurved College, Sangli, K.R. Pandav College of Physiotherapy, Nagpur and Sai Homoeopathic College, Thane.

1. Shri. Annasaheb Dange Ayurved Medical College, Ashta has requested to regularize admissions of 25 candidates, admitted in PG Ayurved Course through institute level CET 2016 conducted as per the rule 13.5.1 of Asso - CET 2015-16 broacher.
2. Shri. K.R. Pandav College of Physiotherapy, Nagpur has requested to regularize admissions of 23 candidates, admitted in UG Physiotherapy Course at Institute Level for which the College is ready to pay the fine if any imposed by Authority.
3. Similarly Sai Homoeopathic College, Thane has requested to regularize admissions of 07 candidates, admitted in UG Homeopathy Course at Institute Level from MHCET 2016. The college has also requested to give hearing vide its letter dated 10/07/2017

The Secretary, Admissions Regulating Authority and the Commissioner, State CET CELL stated that w.r.t. the above colleges/institutes the Admissions Regulating Authority has taken decisions in its Meetings held on 11th April, 2017, 4th May, 2017 and 14th June, 2017, respectively to not to approve the admissions of students admitted at Institute level.

In view of the above, after deliberations, the Authority decides to give hearing to 1. Shri. Annasaheb Dange Ayurved medical college, Ashta, 2. Shri. K.R. Pandav College of Physiotherapy, Nagpur, 3. Sai Homoeopathic College, Thane in the next meeting.

The Authority further directs the office to issue the notice immediately to above colleges/institutes w.r.t. the hearing before Admissions Regulating Authority, without waiting for the approval of Minutes.

Item No. 4: To peruse & to seek directions of Authority on the letter dated 24th April 2017 received from the Assistant Registrar, High Court of Bombay along with Order of Hon'ble High Court dated 15/12/2016 in Writ Petition No. 13015 of 2016 and others regarding the admissions done in PG Ayurved courses through Institute level CET for Academic Year 2015-16.

The Authority perused the Order of Hon'ble High Court dated 15/12/2016 in Writ Petition No. 13015 of 2016 and other joint petitions related to the same issue and clubbed together.

The Authority went through the aforesaid Hon'ble High Court order dated 15/12/2016 in Writ Petition No. 13015 of 2016. The Secretary, Admissions Regulating Authority pointed out the directions of Hon'ble High Court at Para No. 4 as follows :-

Para. 4. In the circumstances, we set aside the impugned order and remit the matter back to the respondent no. 3 for taking a fresh decision regarding approval after issuing show cause notice to the petitioners and giving opportunity of hearing to the petitioners.

In view of the above, after deliberations, the Authority decides to call for the hearing to all the concerned petitioners w.r.t. the Order of Hon'ble High Court dated 15/12/2016 in Writ Petition No. 13015 of 2016 and other similar petitions, in the next meeting of the Authority along with all relevant information before the Authority.

The Authority further directs the office to issue the notice to concerned petitioners in W.P. No. 13015 of 2016 and other clubbed petitions, for hearing before Admissions Regulating Authority immediately, without waiting for the approval of Minutes. Office to take necessary steps.

The Authority also went through the report of Director, Medical Education and Research, Mumbai dated 06-06-2017 submitted in this regard which is attached herewith as **Annexure - B**

The Directorate in its report has concluded that after submitting relevant details that the admission process conducted by the Directorate of Medical Education and Research, Mumbai is always transparent and merit based and therefore there is no merit in the complaint of Ms. Davare.

In view of the above and after deliberations, the Authority decides to accept the report submitted by the Directorate of Medical Education and Research, Mumbai w.r.t. complaint of Ku. Shruti Manik Davare regarding admission process of Health Science Courses for the Academic Year 2015-16 and accordingly the complaint is disposed off. Office to inform accordingly.

Item No. 5(c): Letter dated 13th June 2017 received from Maharashtra University of Health Sciences, Nashik asking for certified list of students admitted in Academic Year 2017-18.

The Authority perused the aforesaid letter dated 13-06-2017 received from the Maharashtra University of Health Sciences, Nashik regarding certified list of students admitted in Academic Year 2017-18.

After deliberations, considering the provisions of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. Act No. XXVIII of 2015) the Authority decides that the verification and approval of admissions will be done as per the Act provisions and informed to concerned colleges as well as to the concerned Universities in due course of time. Maharashtra University of Health Sciences, Nashik may also be informed by the State CET CELL, regarding the admissions done under CAP (i.e. 85%) Quota as per the case may be. Office to inform accordingly to the State CET-CELL and Maharashtra University of Health Sciences, Nashik.

Item No. 5(d): Letter dated 24th June 2017 received from Institute of Medical Sciences and Research, Satara requesting to refund the penalty amount paid by the College w.r.t. approval of admissions of the students admitted in Academic Year 2014-15.

The Authority perused the aforesaid letter dated 24-06-2017, received from the Institute of Medical Sciences and Research, Satara requesting to refund the penalty amount of Rupees One Crore Ninety Lakh, paid by the Institute w.r.t. approval of admissions of the students admitted in Academic Year 2014-15.

The Authority went through the decisions taken by it in its meetings held on i) 6th May 2016, ii) 8th June 2016, iii) 13th July 2016, iv) 27th July 2016, v) 12th August 2016, vi) 30th August 2016 and vii) 21st September 2016.

The Secretary, Admissions Regulating Authority pointed out that as per the decision taken by the Authority in its meeting 6th May 2016 at Item No. 3, Shree Chatrapati Shivaji Education Society, Satara had deposited the part penalty amount of Rs. 1.90 crore in the Authority office; though not in time as directed by the Authority.

It is submitted by the officials of Directorate of Medical Education and Research, Mumbai that Hon'ble Supreme Court of India, New Delhi in the case of Danane Shweta Sunil and Ors. V/s. Union of India and Ors. in Special Leave to Appeal (C) No(s) 29645 of 2016, has imposed the penalty of Rs. 20.00 Crore on the Government of Maharashtra and the Government of Maharashtra accordingly deposited Rs. 20.00 Crore in the registry of Hon'ble Supreme Court. The Institute has submitted vide letter dated 24-06-2017 that the Government of Maharashtra has started to recover penalty amount of Rs. 20.00 Crore from the Institute and for the same reason, two different Government bodies imposing penalty is not just and, therefore, Institute has requested to refund the same and deposit it to the Collectorate of Satara.

In view of the above, after deliberations, the Authority decides to seek information from the Government of Maharashtra/Directorate of Medical Education and Research, Mumbai to whom the penalty amount be handed over. After receipt of it, it will be placed before the Authority for its consideration. Office to inform the Directorate of Medical Education and Research, Mumbai accordingly.

The Director, Technical Education also published a circular informing to all Institutes to publish their advertisements on their Website containing Schedule of admissions, No. of available seats, etc. vide its letter no. 2A/ADM/2017/644 dated 21st June, 2017.

In view of the above, after deliberations, the Authority noted the actions taken by the Director, Technical Education and the Commissioner, State CET-CELL.
