Item No. 3: To discuss and decide on Schedule for the verification and approval of admission process of various professional courses for the Academic Year 2016-17.

The Authority perused the decision taken by it in its meeting held on 13th July 2016 which is as under____

"The attention is drawn to section 9 (5), (i), (ii), (iii) of the provisions of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015; the details of which are as under:

- (i) every unaided institution shall submit the 'admission approval proposals' to the concerned Directorate within fifteen days from the cut-off date of admission;
- (ii) every institution shall submit such proposal certified by the concerned Directorate to the Admissions Regulating Authority within two months from the date of such certification;

(iii) every such proposal received from the Institution by Admissions Regulating Authority shall be scrutinized and approved before the 31st January of every year;

In consonance with the above provisions and looking at the considerable number of Institutes/Colleges and courses under its purview, the time schedule and requirement of fast and efficient process to scrutinize and approve each such proposal, the Authority is of view to adopt online process for submission and verification of such proposals and approval to the students of these professional courses, for the Academic Year 2016-17 and onwards. Accordingly, the Authority office, put forth the proposed online process as under:-

- (i) All unaided private professional Colleges/Institutes should submit their "admissions approval proposals" online, to the Authority portal.
- (ii) The concerned Directorate through its login (provided by the Authority), should scrutinize and verify the admissions details, submitted by the Colleges/Institutes. The Directorate should submit their College wise / Institute wise reports to the Admissions Regulating Authority office, on the same portal.
- (iii) After the scrutiny and verification of such proposals, the concerned Directorate should certify the proposals and submit it to the office of the Authority on the same portal, in the prescribed tabular format; which will be checked and confirmed by the Authority office. Such scrutinized proposals will be placed before the Authority for approval and necessary action.
- (iv) On the basis of the proposals so submitted, the Authority may approve/disapprove the admissions of the Colleges/Institutes. The list of students, whose admissions are approved or disapproved or where there are discrepancies, then subject to compliances of such discrepancies to the concerned Directorate or to the Authority office, as the case may be, will be sent to the Colleges/Institutes by the Authority office with suitable remarks/directions and to the concerned University as well as to the Social Welfare Department as the case may be, for further necessary action.

In view of the above, after deliberations, the Authority decides to call for the views/suggestions from all concerned Directorates on the above proposal within 10 days. After receipt of the views/suggestions of the Directorates, it may be placed before the Authority for its consideration. Office to inform accordingly."

The Secretary, Admissions Regulating Authority submitted that the above decision of the Authority was communicated vide letter no. प्राधिकरण/१३ जुलै/प्रवेश प्रक्रिया/२८८४ दि. २२ जुलै २०१६ to a) the Director, Medical Education and Research b) Director, Technical Education, c) Director, Higher Education and d) Director, Ayush. As no reply was received from all the concerned Directorates it was informed to them vide D.O. Letter of Secretary, Admissions Regulating Authority no. प्राधिकरण/१३ जुलै/प्रवेश प्रक्रिया/०१०, दि. ९ ऑगस्ट २०१६. However till date no reply from all the Directorates has been received.

The Director, Medical Education and Research, Mumbai and Asst. Director, Department of AYUSH stated that they have followed the decision of the Authority in its meeting held on 13th July, 2016 in respect of verification and approval of admission process of various professional courses for the Academic Year 2016-17.

In view of the above, after deliberations, the Authority directs that all concerned Directorates should follow the directions of the Authority given in its meeting held on 13th July, 2016 in respect of the verification and approval of admission process of various professional course for the Academic Year 2016-17.

The Authority further directs to all Private professional Colleges/Institutes as follows:-

- 1. Every Unaided College/Institute shall submit the admission approval proposals to the concerned Directorate within fifteen days from the cut off date of admission.
- 2. After verification by the concerned Directorate, the College/Institute should submit immediately such proposals to Admissions Regulating Authority for Approval latest by 30th November, 2016.
- 3. The College/Institute should submit its proposal within the given time frame. Authority may charge the College/Institute processing fees as well as late fees, if there is delay in submission of the proposal.

Office to take necessary steps and inform the all concerned accordingly.

A) Medical Education

Item No. 4:

To discuss and decide in respect of the decision taken by the Authority in its meeting held on 30th August, 2016 (at Item No. 4 and 5 regarding non submission of sanction letter of loan approval of the Bank.).

The Authority went through the decisions taken by it in its meetings held on i) 6^{th} May 2016, ii) 8^{th} June 2016, iii) 13^{th} July 2016, iv) 27^{th} July 2016, v) 12^{th} August 2016 and vi) 30^{th} August 2016.

The Authority observes that the Institute of Medical Sciences and Research, Satara has failed to submit the clear and final sanction letter of loan approval of the bank to the Authority, even after the additional one week time given after 30^{th} August, 2016.

In view of the above, after deliberations, the Authority decides that the decisions taken by the Authority regarding the provisional approval w.r.t. the students admitted in Institute of Medical Sciences and Research, Satara for First Year MBBS course hereinbefore for the Academic Year 2014-15 stands cancelled. Office to inform accordingly.

Item No. 5:

To apprise the Authority regarding Writ Petitions filed by a) Shree Chatrapati Shivaji Education Society's Institute of Medical Science and Research, Mayani, Satara Writ Petition no. 24493/2016 and b) Shaswat Rathore and others Writ Petition no. 25322/2016.

The Secretary, Admissions Regulating Authority, Mumbai submitted that a) Shree Chhatrapati Shivaji Education Society's Institute of Medical Sciences and Research, Mayani, Satara and b) Shaswat Rathore filed Writ Petition No. 24493 of 2016 and 25322 of 2016, respectively in Hon'ble High court Bombay. Shree Chhatrapati Shivaji Education Society, Satara filed the petition against Admissions Regulating Authority to reduce the penalty amount imposed by the Authority in its meeting held on 6th May, 2016 (at Item No. 3), whereas Shri. Shaswat Rathore filed the petition for approval of their admissions and for declaration of results of Ist Year M.B.B.S. The Authority noted that the above matters are sub-judice and pending before the Court.

In view of the above, after deliberations, the Authority directed to place before the Authority the orders of Hon'ble High court in this regard, if any in its next meeting.

In view of the above, after deliberations, the Authority approves the admissions of four students 1. Jain Palak Pravinkumar, 2. Mungase Shubdha Dipak, 3. Jadhav Apurva Gautam, 4. Maligouda Pooja Shashidhar admitted on the basis of MH-CET-2015

for the First Year B.P.Th. course for the Academic Year 2015-16, subject to fulfillment of eligibility conditions laid down by the respective Authorities. Office to inform accordingly.

<u>Item No. 6(d)</u>:

Letter dated 26th August, 2016 received from Dr. G.D. Pol Foundation, Y.M.T. Dental College and Hospital, Navi Mumbai asking for Eligibility of admitted students through PGD-CET candidates for Academic Year 2015-16.

The Authority perused the aforesaid letter received from Dr. G.D. Pol Foundation, Y.M.T. Dental College and Hospital, Navi Mumbai requesting to approve the admissions of admitted students on the basis of other than APGD-CET-2015 to Post Graduate Dental Courses for the Academic Year 2015-16.

The Authority observes that the aforesaid College has opted for the admission process conducted by Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra on the basis of results of APGD-CET-2015 for admissions to Post Graduate MDS course for the Academic Year 2015-16. But the College/Institute has admitted 1. Dr. Kulkarni Anuja Sanjay, 2. Dr. Sheth Darsh Haren through PGD-CET-2015 for Academic Year 2015-16.

In view of the above, after deliberations, the Authority directs the aforesaid College/Institute to submit sufficient evidence regarding no qualified students as per APGD-CET-2015 and the list of qualified students through APGD-CET-2015 has been exhausted fully for Academic Year 2015-16 for Post Graduate Dental courses, duly certified by the Competent Authority, Association of Management of Unaided Private Medical & Dental Colleges of Maharashtra along with affidavit explaining therein following points:-

- a) That the list of candidates qualified from the APGD-CET-2015 had exhausted, and therefore, College/Institute admitted the candidates from another CET by following set procedure.
- b) Sufficient advertisements for filling in vacant seats were also given in leading newspapers and was published on website as well as notice board too.
- c) That no meritorious candidates of APGD-CET-2015 were denied admissions.
- d) That no candidate of APGD-CET-2015 has filed any complaint against College for Post Graduate Dental admissions.

After receipt of the same it will be placed before the Authority for its consideration. Office to inform accordingly.

Letter dated 6th September, 2016 received from Terna Medical College and Hospital, Navi Mumbai requesting to grant approval to the admission of Miss. Devyani Kishor Shegokar, SC Candidate vice, Miss. Sonal Wankhede, SC Candidate for the Academic Year 2015-16.

The Authority perused the aforesaid letter received from Terna Medical College, Navi Mumbai asking for approval to the admission of Miss. Devyani Kishor Shegokar admitted in SC category in First Year MBBS course for the Academic Year 2015-16.

The Authority went through the decision taken by it in its meeting held on 23rd July, 2016 along with verification report dated 9th June, 2016 submitted by the Directorate of Medical Education and Research, Mumbai.

It is noticed that the Expert Committee i.e. the Directorate of Medical Education and Research, Mumbai in its report dated 9/06/2016 stated that the aforesaid College/Institute selected one candidate (SML: 1081 Wankhede Sonal: Category SC), it is shown in the selection list of Terna Dental College, Navi Mumbai against SC seat.

The aforesaid college vide its letter under reference stated that Miss. Sonal Wankhede was selected on 24-09-2016 and on 25-09-2015 the said Miss. Wankhede cancelled her admission vide her letter dated 25-09-2015 and the said vacant seat was filled by Miss. Devyani Kishor Shegokar on 30-09-2015 for Academic Year 2015-16 and further requested to grant approval of the admission of Miss. Devyani Kishor Shegokar (SC) for the Academic Year 2015-16.

In view of the above, after deliberations, the Authority accedes to the request made by the aforesaid College/Institute and approve the admission of Miss. Devyani Kishor Shegokar in First Year MBBS course for the Academic Year 2015-16, subject to fulfillment of the eligibility norms laid down by the concerned Authorities. Office to inform accordingly.

Item No. 6(f):

Letter dated 2nd September, 2016 received from Late Shri Yashwantrao Chavan Memorial Medical and Rural Development Foundation's Dental College & Hospital, Ahmednagar asking for permission to admit candidate on vacant seats Eligible from NEET merit list, from out of Maharashtra State Candidate for Academic Year 2017-18 for first year B.D.S. Course.

The Authority perused the aforesaid letter received from Late Shri Yashwantrao Chavan Memorial Medical and Rural Development Foundation's Dental College and Hospital, Ahmednagar asking for permission to admit candidate on vacant seats eligible from NEET merit list, from out of Maharashtra State candidate for Academic Year 2017-18.

After deliberations, the Authority directs to adjourn and place the matter before it in its next meeting, for consideration.

Item No. 7:

Letter dated 12th September, 2016 received from Maharashtra University of Health Science, Nashik regarding Registration and Eligibility of Students of Private Unaided Health Science, Colleges which admitted students in 15% NRI Quota for the Academic Year 2012-13, 2013-14, 2014-15 & 2015-16.

The Authority perused the aforesaid letter received from the Maharashtra University of Health Sciences, Nashik regarding registration and eligibility of students admitted in 15% NRI Quota for the Academic Year 2012-13, 2013-14, 2014-15 and 2015-16.

It is noticed that various admissions of admitted students in 15% NRI Quota in Academic Year 2012-13, 2013-14, 2014-15 and 2015-16 was pending for approval and due to non approval of such admissions, result are withheld by the Maharashtra University of Health Sciences, Nashik.

The Secretary, Admissions Regulating Authority submitted that various Colleges/Institutes have not complied with the requisite documents regarding NRI Quota admissions and therefore have not been approved by the Authority. The Secretary further added that due to shortage of manpower, the proposals are pending for scrutiny and verification.

The Asst. Registrar, Maharashtra University of Health Sciences, Nashik who attended the meeting on behalf of the Registrar, Maharashtra University of Health Sciences, Nashik, pointed out that the result of NRI students appeared for Summer—2016 Medical Examination has not been declared so far and the dates of submission of forms for Supplementary Examination to the Colleges and University are 17-09-2016 and 22-09-2016, respectively, and further requested that the result of the students, failed in this Examination may be allowed to be declared.

In view of the above, after deliberations, the Authority directs the office of the Authority to verify and scrutinize all pending proposals of admitted students in 15% NRI Quota at the earliest and submit the report to the Authority. The decision of the Authority be conveyed accordingly to the Maharashtra University of Health Sciences, Nashik for further necessary action.

B) Higher and Technical Education:

Item No. 8:

Letter dated 31st August, 2016 received from Council of Architecture, New Delhi regarding admission of students in 1st Year of 5-year B. Architecture degree course. [Minutes of the meeting dated 30th August, 2016 Item no. 12].

The Authority perused the aforesaid letter received from the Council of Architecture, New Delhi regarding admission of students in $\mathbf{1}^{\text{st}}$ Year of 5 Year B. Architecture degree course.

The Authority went through the decision taken by it in its meeting held on 30th August, 2016 at Item No. 12.

It is pointed out that as per the clause 1 para No. 3 of All India Council for Technical Education (AICTE) 'Approval Process Handbook 2016-2017' B. Architecture education was also placed under the purview of AICTE. As per the Hon'ble Supreme Court Judgment in Civil Appeal No. 9048 of 2012 and Writ Petition No. (Civil) No. 538 of 2014, the cut-off-date for admissions is 15th August. The Cut-Off date which CET Cell has declared in its Admission Notice is 14th August 2016 (As 15th August is a National Holiday), as per AICTE guidelines and the Supreme Court Judgment.

After deliberations, the Authority concludes that the decision taken by the Authority in its meeting held on 30th August, 2016 at Item No. 12 warrants no change. Office to inform accordingly.

Item No. 9:

Letter dated 13th September, 2016 received from Maharashtra Association of Schools of Architecture (MASA), Pune submitting resolution regarding withdrawal of Writ Petition no. 5468/2015 filed in the Hon'ble High Court of Mumbai in respect of admission process for the Academic Year 2015-16. [Minutes of the Meeting dated 30th August, 2016 Item No. 16(a)].

The Authority perused the aforesaid letter received from Maharashtra Association of Schools of Architecture (MASA), Pune submitting resolution regarding withdrawal of Writ Petition No. 5468 of 2015 filed in the Hon'ble High Court of Mumbai in respect of admission process for the Academic Year 2015-16.

The Authority went through the decision taken by it in its meeting held on 30th August, 2016 at Item No. 16(a).

It is noticed that the aforesaid Association has withdrawn the Writ Petition No. 5468 of 2015 filed in the Hon'ble High Court of Mumbai in respect of admission process for the Academic Year 2015-16.

In view of the above, after deliberations, the Authority directs the Directorate of Technical Education, Mumbai to verify and scrutinize the admission process of B. Architecture course for the Academic Year 2015-16 conducted by Maharashtra Association of Schools of Architecture, Pune for individual Colleges/Institutes and the Directorate should submit its report to the Authority within 10 days. After receipt, it may be placed before the Authority in its next meeting for consideration. Office to take necessary steps and inform accordingly.

Item No. 10:

To confirm and approve the decision taken by the Secretary, Admissions Regulating Authority on the various proposals received from Degree Technical Institutions for Transfer of Candidates (Course/Institute) for Degree Courses for the Academic Year 2016-17 along with office note dated 17/09/2016.

The Authority perused the report dated 7th September, 2016 received from The Directorate of Technical Education, Mumbai regarding transfer of candidates (Course/Institutions) in Unaided Private Professional Diploma Technical Courses for the Academic Year 2016-17.

The Authority went through the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Diploma Technical Courses) Rules, 2016, 16(2).

As per the provisions of Rule, 16(2) the Principals of the Professional Diploma Technical Institutes submitted the applications of transfer of students with their recommendations to office of the Admissions Regulating Authority. These Applications were forwarded to the Director, Technical Education M.S., Mumbai for verification and observations.

The Authority in its previous meeting held on 27^{th} July, 2016 had empowered the Secretary, Admissions Regulating Authority to approve the transfer of candidates (Course/institutes). The Director, Technical Education submitted its report on 7^{th} September, 2016. As per the observation report, with office note dated 17^{th} September, 2016, the Secretary, Admission Regulating Authority approved the same.

After deliberations, the decision of approval of the transfer of Candidates (Course/Institutions) in Unaided Private Professional Diploma Technical Courses with no discrepancies for Academic Year 2016-17 is ratified, subject to compliance of the Rules, Regulations, Terms and Conditions laid down earlier by the Government of Maharashtra and the Directorate of Technical Education, Mumbai. Marked as **Annexure A and B.**

The Admissions Regulating Authority further decides that in respect approval of transfer of candidates for Second Year B. Engineering/ B. Pharmacy will be declared after the final updating of Direct Second Year Admission Process. The Authority further direct the admitting colleges as well as parent colleges updates their vacancy position



and No objection certificate (NOC) given to the candidates who were applied for transfer, after the Direct Second Year Admission process over. Then after the proposals for transfer of candidates for second year will be considered.

The Authority further directed to the office to declare the above approved list on websites of the Admissions Regulating Authority and of the Director, Technical Education M.S., Mumbai.

<u>Item No. 11:</u>

Letter dated 14th September, 2016 received from Director, Technical Education, Mumbai asking for confirmation of admission of allotted students but not yet reported to allotted college for First year of Diploma Engineering course in Academic Year 2016-17. (Ku. Dipali Satish Pote - DEN16276749)

The Authority perused the aforesaid letter received from Director, Technical Education, Mumbai asking for confirmation of admission of allotted student viz. – Ku. Dipali Satish Pote (DEN16276749) but not yet reported to allotted college for First Year of Diploma Engineering course in Academic Year 2016-17.

The Director, Technical Education, Mumbai in its aforesaid letter stated that Ku. Dipali Pote allotted from a seat for Diploma Polytechnic course from 'Common Admission Process' to S.H. Jondhale Polytechnic, Dombivali. The admission was confirmed with ARC, but the admission was not seemed to be confirmed by the Institute.

However, the request can not be consider at this stage for want of additional data from Director, Technical of Education, Mumbai.

Item No. 12:

Letter dated 17th September, 2016 received from the Directorate of Technical Education, Mumbai regarding verification report on transfer of candidates (Course/Institutes) of Engineering/Pharmacy/Architecture/HMCT Courses for Academic Year 2016-17.

The Authority perused the proposals received from Undergraduate Technical Institutions for transfer of candidates (course/institute) for Degree Engineering/Pharmacy/Architecture/HMCT Courses for the Academic Year 2016-17.

The Authority went through the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions to the Full Time Professional Undergraduate Technical Courses) Rules, 2016 rule no. 17 (2) published on 11th March 2016.

As per the provisions of Rule 17 (2) the Principals of the Professional Undergraduate Technical Institutes submitted the applications of transfer of students with their recommendations to office of the Admissions Regulating Authority. These

applications were forwarded to the Director, Technical Education M.S., Mumbai for verification and observations.

The Director submitted its report on 17th September, 2016.

The Admissions Regulating Authority perused observation report of the Director, Technical Education M.S., Mumbai. The Admissions Regulating Authority, after deliberations decided to approve the transfer of Candidates (Course/Institutions) in Unaided Private Professional Undergraduate Technical Courses with no discrepancies for Academic Year 2016-17, subject to compliance of the Rules, Regulations, Terms and Conditions laid down earlier by the Government of Maharashtra and the Directorate of Technical Education, Mumbai, the details of which are marked as **Annexure - C.**

The Admissions Regulating Authority also decided not to approve the transfer of candidates (course/institutions) in Unaided Professional Undergraduate Technical Courses where there are discrepancies, the details of which are marked as **Annexure – D.**

The Admissions Regulating Authority further decided that in respect approval of transfer of candidates for Second Year B. Engineering/ B. Pharmacy will be declared after the final updating of Direct Second Year Admission Process. The Authority further directed that the admitting colleges as well as parent colleges to update their vacancy positions and No objection certificate (NOC) given to the candidates who had applied for transfer, after the Direct Second Year Admission process is over. Then after the proposals for transfer of candidates for second year will be considered.

The Authority further directed the office to declare the approved as well as not approved list on websites of the Admissions Regulating Authority and of the Director, Technical Education M.S., Mumbai.

<u>Item No. 13</u>: <u>To consider and decide on following letters/representations:-</u>

Item No. 13(a): Letter dated 1st September, 2016 received from Chembur Trombay Education Society's CTES College of Architecture, Mumbai asking for approval of admitted students against vacant seat after Cut off date for B. Architecture course, Academic Year 2016-17.

The Authority perused the aforesaid letter received from Chembur Trombay Education Society's CTES College of Architecture, Mumbai asking for approval of admitted students against vacant seat after cut-off-date for B. Architecture course, Academic Year 2016-17.

The aforesaid college in its letter stated that one candidate Mallika Gupta has cancelled her admission on 22-08-2016. Thereafter another candidate Suthar was admitted against cancellation and he also cancelled his admission on 29-08-2016. So the

College/Institute decided to admit Mishkin Rajesh Mande against that vacancy and seeking approval of it of the Authority.

It is observed that as per submission by the college, Mishkin Rajesh Mande was to be admitted against vacant seat after the cut-off-date for B. Architecture course for the Academic Year 2016-17.

In view of the above, after deliberations, the Authority decides not to approve the admission of Mishkin Rajesh Mande admitted after the cut-off-date. Office to inform accordingly.

Item No. 13(b): Letter dated 30th August, 2016 received from Brahmdevdada Mane Institute of Technology, Solapur requesting to approve the admission of Vibhute Mahanteshwar Shreeshail, OBC admitted in OPEN Quota for MBA course in Academic Year 2016-17.

The Authority perused the aforesaid letter received from Brahmdevdada Mane Institute of Technology, Solapur requesting to approve the admission of OBC candidate viz. - Vibhute Mahanteshwar Shreeshail admitted in Open quota for MBA course in Academic Year 2016-17.

The aforesaid college in its letter stated that at the time of registration for admission process for MBA course the candidate viz. - Ku. Vibhute Mahateshwar Shreeshail applied in open category, however in after the B.Sc. degree result he did not secure requisite marks i.e. he got less than 50%. Hence college requested to consider his admission in OBC category, instead of open category.

In view of the above, after deliberations, the Authority comes to the conclusion that the request made by the aforesaid College/Institute to approve the admission of Ku. Vibhute Mahateshwar Shreeshail in OBC category cannot be acceded to. Office to inform accordingly.

Item No. 14: To peruse the statement of Accounts submitted by Office of the Commissioner, State CET-CELL, for the period of 10-08-2016 to 20-09-2016.

The Authority noted the following statement of Accounts submitted by the State CET-CELL, for the period 10/08/2016 to 20/09/2016. The details of which are marked as **Annexure - E**.

Item No. 15:

To discuss and decide on requests received from various candidates regarding refund of Seat Acceptance Charges (Rs. 5000/- or Rs. 3000/- as applicable) for the students who have not reported to institutes and not taken admission for the Academic Year 2016-17 in Technical Courses.

The Commissioner, State CET-CELL, Mumbai submitted that as per the admission rule No. 9(1-h) for UG/PG and 8(1-h) for Diploma, the candidate (of General, VJ/DT, NT, SBC/OBC Category), who is offered seat as per allotment of the CAP round, was required to report to Admission Reporting Center (ARC) and pay Rs. 5000/- (Rs. 3000/-for Diploma) as 'Admission Acceptance Fee' as applicable while the candidate belonging to SC/ST category was required to pay Rs. 1000/- as Seat Acceptance Fee by Demand Draft (DD).

All the candidates who have reported at ARC were also required to report to the allotted institute during the period as indicated in respective published admission schedule and confirm the admission as per admission rule 8(4) for Diploma and 9(4) for Under Graduate and Post Graduate Admissions before cut-off date.

After deducting the processing charges of Rs. 1000/-, the State CET Cell is required to transfer the remaining amount to respective institute as part of fees. But many students have completed ARC reporting but did not report to the allotted institute due to various reasons such as 'not interested in taking admission in allotted institute etc".

The State CET-CELL is in receipt of applications from number of candidates requesting refund of Rs. 5000/- , as they have not reported to the institute and have not confirmed the admissions.

Therefore, the Commissioner, State CET-CELL proposed the Authority to return the balance amount after deducting Rs. 1000/- as processing charges and any other charges required for refund of the amount (such as Bank Commission, RTGS charges etc. as actual) from the DD amount after actual reflection of such amount in the account of the State CET-CELL, to such candidates who approach to the office of the State CET-CELL.

In view of the above, after deliberations, the Authority approved the request made by the Commissioner, State CET-CELL. Office of the Commissioner, State CET-CELL to take necessary steps.

Item No. 16: To consider and decide on the following matters with the

<u>Item No. 16(a)</u>: <u>Letter dated 12th September, 2016 received from Higher</u>

and Technical Education Department, Mumbai regarding transfer of admission of Ku. Nihar Shah from Rajsthan to

The Authority perused the aforesaid letter received from the Higher and Technical Education Department, Mumbai regarding transfer of admission of Ku. Nihar Shah from Rajsthan to Maharashtra in second year degree admission.

The Authority went through the decision taken by it in its meetings held on 27^{th} July, 2016 - at item No. 15(f) and 30^{th} August, 2016 - at item No. 7.

It is noticed that the Government of Maharashtra through Higher and Technical Education Department vide its aforesaid letter requested to consider the transfer admission of Ku. Nihar Shah from Rajsthan to Maharashtra as a special case.

The Authority also went through the provisions of "The Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Technical Courses) Rules, 2016", dated 11th March 2016,

The Authority made it clear that there is no provision for special case in the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Undergraduate Technical Courses) Rules, 2016", dated 11th March 2016.

In view of the above, after deliberations, the Authority concludes that the decisions taken by the Authority in its meetings held on 27^{th} July, 2016 - at item No. 15(f) and 30^{th} August, 2016 - at item No. 7 warrants no change. Authority further concludes that Government of Maharashtra may take appropriate decision in this regard. Office to inform accordingly.

Item No. 16(b): Letter dated 20th September, 2016 received from SMBT

Institute of Dental Sciences and Research, Nashik asking
for permission to include the College/Institute (New
College) in 'Common Admission Process' for the Academic
Year 2016-17.

The Authority perused the aforesaid letter received from SMBT Institute of Dental Sciences and Research, Nashik asking for permission to allow us to fill up the seats at Institutional level as CAP round for the admissions to First Year BDS course for the Academic Year 2016-17.

It is noticed that aforesaid College/Institute has not received the first affiliation from the Maharashtra University of Health Sciences, Nashik for the admission First Year BDS course for the Academic Year 2016-17.

It is also pointed out that First Selection list (Round - I) of 'Common Admission Process' of NEET-UG-CET-2016 was already over and State CET-CELL has not obtained the preferences from desirous candidates for the said College and now it's not possible to take fresh preferences for the said college/Institute from the candidates.

In view of the above, after deliberations, the Authority decides request made by the aforesaid College/Institute to include the College/Institute (New College) in "Common Admission Process" for the Academic Year 2016-17 cannot be acceded to. Office to inform accordingly.

Item No. 16(c): Letter dated 17th September, 2016 received from Bhausaheb Mulak Ayurved Mahavidyalaya, Nagpur regarding correction in the number of eligibility of PG admitted students in Academic Year 2015-16 (Ref.: Minutes of the meeting dated 8th June, 2016 at Item No. 14(a)).

The Authority perused the aforesaid letter received from Bhausaheb Mulak Ayurved Mahavidyalaya, Nagpur asking for correction in number of eligibility of PG admitted students in Academic Year 2015-16.

The Authority went through the decision taken by the Authority in its meeting held on 8th June, 2016 at Item No. 14(a).

The aforesaid College/Institute in its letter stated that they admitted 19 students through Associate CET and only 04 students through College level CET for the Post Graduate Ayurved course for the Academic Year 2015-16.

In view of the above, the Authority accede to the request made by college as 19 students admitted through Asso-CET and 04 students admitted through college level CET. Authority further decides to approve the admissions of 19 students admitted through Association CET for the Post Graduate Ayurved course for the Academic Year 2015-16, subject to fulfillment of eligibility criteria laid down by the respective Authorities. Office to inform accordingly.

Item No. 16(f): To consider and decide on the Verification/Observation report dated 21st September, 2016 received from Directorate of Medical Education and Research, Mumbai.

The Admissions Regulating Authority perused the observation report w.r.t. MBBS (03 Colleges), BDS (01 College), B.Sc. Nursing (16 Colleges) and B.P. Th. (08 College) submitted by the Directorate of Medical Education and Research, Mumbai having found no discrepancies in admission process of these Under Graduate Courses for the Academic Year 2015-16.

It is noticed that Directorate in its verification report dated 21/09/2016 pointed out that various B.Sc. Nursing Colleges/Institutes, admitted students from both the lists i.e. MH-CET-2015, Asso-CET-2015 and also admitted Non-CET students during the admission process.

The Authority perused the Government Resolution No. एमईडी १०१५/प्र.क्र. ७६/१५/शिक्षण – २, dated 29th April 2015, in this regard.

After, deliberations, the Authority decides to approve admissions of B.Sc. Nursing course as per the provisions of Government Resolution dated 29/04/2015 which is effective for Academic Year 2015-16 and on the basis of verification and observation report of Directorate of Medical Education & Research, Mumbai (in which the admissions have been approved). However the Directorate should sort out and dispose off with the discrepancies after appropriate compliances within two weeks from respective College/Institute.

Item No. 16(g): Letter dated 8th September, 2016 received from Director, Technical Education, Mumbai asking for confirmation of admission of allotted students but not yet reported to allotted college for Direct Second Year of Diploma Engineering course in Academic Year 2016-17.

The Authority perused the aforesaid letter received from Director, Technical Education, Mumbai asking for confirmation of admission of allotted student but not yet confirm to allotted Govt. Aided/Private Unaided colleges/institutes for First Year and Direct Second Year of Diploma Engineering course in Academic Year 2016-17.

The Director, Technical Education, Mumbai in its aforesaid letter stated that students were allotted seat for First Year and Direct Second Year Diploma Polytechnic from 'Common Process' Aided/Private Admission to Govt. colleges/institutes. The admission was confirmed with ARC, but the admission was not seemed to have been confirmed by the Colleges/Institutes.

However, the request can not be consider at this stage for want of additional data from Director, Technical of Education, Mumbai.
