- i) As shown in column no. 4, out of total expected 3515 Institutes/Colleges of Higher and Technical Education, 1023 institutes and out of total expected 376 Institutes/Colleges of Health Science courses, 66 Institutes/Colleges have not submitted their admissions details online.
- ii) As shown in column no. 6, out of total expected 3515 Institutes/Colleges of Higher and Technical Education 1919 Institutes/Colleges and out of total 376 Institutes/Colleges of Medical Education 114 Institutes have submitted their proposals in the office of Admissions Regulating Authority for approval of admissions duly certified by concerned Directorates.
- iii) As shown in column 07 of table 'A', the total no. of 860 Higher and Technical Education and of table 'B' the total no. of 74 proposals of Medical Education were scrutinized and put for approval of admissions before Authority, the details of these proposals are given in Item No. 19 & 13, respectively.

- iv) As shown in column no. 10 of table 'A' total no. of 1059 and column No. 11 of table 'B' total no. of 17 proposals for approval of admissions are under scrutiny of office.
- v) As shown in column no. 11 of table 'A' total no. of 1596 and column No. 12 of table 'B' total no. of 262 proposals for approval of admission yet not submitted by the Colleges/Institutes.

It is noticed that the verification process of admissions of all respective colleges from concerned directorates has not been completed, as per the Act provision.

After deliberations, the Authority decides as follows:-

- 1. To extend and to allow the Colleges/Institutes to submit their admission details online upto 12th February 2018 for the Academic Year 2017-18, subject to payment of penalty @ 20% on total 'Processing Fees', as approved by the Authority in its meeting held on 14th December 2017 at Item No. 3.
- 2. To permit the Colleges/Institutes to submit the proposals for approval of admissions upto 12th February 2018 duly certified by concerned directorates in prescribed format. The concerned Directorate will scrutinize the admission proposals and also check all relevant documents along with Non-creamy Layer Certificate, Caste Validity Certificate, etc.
- 3. To submit the proposals along with report of Directorates for approval of Authority, which are under scrutiny of Office of the Authority.
- 4. In continuation to the above, the Authority decides that the Colleges/Institutes who have failed to submit such details of admissions online and proposals for approval of admissions within prescribed time limit, may not be considered for approval of the Authority and admissions of such Colleges/Institutes shall be deemed to be rejected, without further intimation, which may be noted by the College/Institute and the Students/Parents concerned.

The Authority further directs the office to inform the above decision of the Authority to all concerned Directorates, Universities, Colleges/Institutes. The concerned Colleges/Institutes will inform this decision to the students/parents. Office to take necessary action.

Item No. 4:

To discuss and decide on the letter dated 15th November, 2017 of Higher and Technical Education Dept. Mantralaya, Mumbai regarding reimbursement of grants given by Government towards salary of Govt. Employees of Admissions Regulating Authority & State CET Cell.

The Authority perused the details of the grants sanctioned by the Government of Maharashtra for the salary of Government employees of the Admissions Regulating Authority and the State CET-CELL for the Financial Year 2016-17.

Item No. 5:

To discuss about the accommodation of the Commissioner, State CET Cell in Mumbai at Bandra, where the suitable space taken on rental basis for the Members of the ARA and Special Invitee officers appointed for various work related to the Authority. (Ref. Minutes of meeting dated 14/12/2017 at Item no. 4).

The Authority went through the decision taken by the Authority in its meeting dated 14-12-2017 at Item No. 4.

The Commissioner, State CET-CELL stated that the suitable place for accommodation for the Members/Officers, those who come to Mumbai from remote places to assist and work for the Authority is identified and issituated at Bandra, Mumbai. The residence (02 BHK) of Shri Vipin Digamber Gapchup, at 303, Renuka Co-Operative H.S. Ltd, CTC No. 6239, Plot No. 1274, Bandra (E), Mumbai - 400 051 with rent of Rs. 70,000/- per month and deposit of Rs. 3,50,000/- for the period of 01-01-2018 to 30-11-2018; is found convenient and appropriate and hence taken on rent since 01-01-2018. He further added that as the residential accommodation is not has been allotted by the Government of Maharashtra in Mumbai to the Commissioner, State CET-CELL and the Secretary, Admissions Regulating Authority, the said residence has been occupied by the Commissioner, State CET-CELL since 01-01-2018 and may be allowed to occupy till the Commissioner is allotted the accommodation by the Government of Maharashtra.

After deliberations, the Authority approved the same and directed the office of Authority and State CET-CELL to take necessary action.

Item No. 6:

To discuss on verification report of admissions done in Unaided Private Professional Courses to be submitted in specified formats from various Directorates for Approval of Admissions from AY 2017-18.

The Authority perused the minutes of the meeting held under the Chairmanship of the Secretary, Admissions Regulating Authority on 11-12-2017 regarding verification report of admissions done in Private Professional Courses to be submitted in specified formats from various Directorates, for Approval of Admissions from Academic Year 2017-18.

The Secretary, Admissions Regulating Authority pointed out that while verifying Admission Approval Proposals, by respective Directorates, following points are required to be verified by the Directorates:-

- i) Permissions from respective Authorities like AICTE/MCI/DCI/INC/COA/PCI/etc.
- ii) Affiliation of concerned Universities.
- iii) Sanctioned intake capacity of professional courses.
- iv) Admission procedure adopted followed, as notified by the Government from time to time.
- v) Whether Eligibility criteria of admission is fulfilled.
- vi) Verification from Original documents, which are required for his/her candidature and admission to that Course (Candidate wise)

The verification and observation report of concerned Directorates which will be submitted to Admissions Regulating Authority should be,-

- i) Institute wise, Course wise and student wise,
- ii) Clear cut recommendation of the Director/Competent Authority with details/discrepancies, if any
- iii) The complete list of admitted students in prescribed formats with Certification of concerned Directorates,
- iv) The discrepancies (Student wise) w.r.t. the admitted students should be clearly notified in the report.

After deliberations, the Authority approves as proposed above and also the uniformity in submission and verification of admission approval proposals, as discussed above. The Authority directs the Secretary, Admissions Regulating Authority to take the necessary action in this respect.

The Authority further directs the Directorates and the Institutes/Colleges to follow the provisions of the Act, 2015 in respect of the verification and submission of proposals for approval of admissions.

Item No. 7: To ratify the decision taken by Secretary, Admissions Regulating Authority vide office note dated 4/01/2018 to open the link for uploading the admission details online for Academic Year 2015-16 and 2016-17. (Ref. Minutes of Meeting dated 11/10/2017, 16/11/2017, 14/12/2017)

The Directorates to inform the same to the respective Universities with copy to the Authority office, without fail.

The Authority also made it clear that the admissions so approved, subject to compliance of the discrepancies at respective Directorates, the whole responsibility of compliance of such cases remain with the College/Institute and the concerned students. Office to inform to the Directorates and Universities.

Item No. 10:
