Item No. 3: To decide on the colleges/institutes who did not submitted the Proposals for Approval of Admissions before the Authority for the Academic Year 2017-18.

The Secretary, Admissions Regulating Authority submitted that total 1120 Professional Educational Institutions of Health Science and Higher and Technical course not submitted the proposals for approval of admissions before the Authority for the Academic Year 2017-18.

The Secretary stated that all opportunities have been given to the Colleges/Institutes and also time to time the dates were extended for submission of proposal for approval of admissions.

The Authority went through the decision in its meeting held on 28/03/2018 (at Item No. 3 (2)).

In view of the above, after deliberations, the Authority decides that the Colleges/Institutes who have failed to submit the admissions details online and proposals for approval of admissions, within prescribed time limit, will not be entertained for approval of admissions, the details of which are marked as **Annexure – A.**

The Authority further directs the office to inform the above decision of the Authority to all concerned Directorates, Universities, Colleges/Institutes. The concerned Colleges/Institutes will inform the decision to the students/parents. Office to take necessary action.

Item No. 4: To consider and decide on the Tax Invoice dated 22nd March 2018 received from M/s. Tikekar and Associates LLP w.r.t. the issuing of Internal Audit Report.

Rajendra Patil while submission of admission details on University portal, therefore the University has not given the eligibility to Ku. Sakshi Rajendra Patil students of First Year B.P.Th. course.

The Authority went through the earlier decision taken by the Authority in its meeting held on 24/01/2018 w.r.t. the approval of admissions of the said College.

The Authority further made it clear that for typographical human error should be sorted out by the College with the Maharashtra University of Health Sciences, Nashik at their end and not to refer such type of matters before the Authority. Office to inform accordingly.

"5. Amount of Penalty of Rs. 50,000/- (Rupees Fifty thousand only) be charged to the institute to restore the admission details on website of the candidate who allotted in Institute Level. Payment should be paid in the form of Demand Draft/Pay Order in favour of "The Secretary, Admissions Regulating Authority, Mumbai" payable at Mumbai."

After deliberations, the Authority decides to charge the amount of penalty of Rs. 10,000/- (Rupees Ten thousand only) instead of Rs. 50,000/- (Rupees Fifty thousand only) to the Institute to restore the admission of the candidate who allotted in Institute Level. Payment should be paid in the form of Demand Draft/Pay Order in favour of "The Secretary, Admissions Regulating Authority, Mumbai" payable at Mumbai. Office to take necessary steps and inform accordingly.

In view of the above, after deliberations, on the basis of enquiry report of the Director, Technical Education, Mumbai, the Authority decides to impose a penalty of Rs.1,00,000/- (Rupees One Lakh only) to the Institute to not follow the rules of admission procedure laid down for institute level admissions. Payment should be paid in the form of Demand Draft/Pay Order in favour of "The Secretary, Admissions Regulating Authority, Mumbai" payable at Mumbai. Office to take necessary steps and inform accordingly.


